8.0 GENERAL BUSINESS

8.1 *Christmas Decorations* – Campbell advised that the Shire is likely to contribute \$5000 to the Chamber of Commerce for installation of decorations, including at Tawonga. Could be a good opportunity for Men's Shed.

8.2 *Grant Funds* – Erin Styles (DHS) advised that an agreement will be mailed to us shortly. After signing it and returning it to DHS, 85% of the grant funds should be transferred into our bank account.

8.3 *Painting of Storage Shed* – A request will be made at the BBQ for help to finish the painting of this shed.

8.4 *BBQ Program* – Will show videos at the BBQ, including the one sent by Andrew and John H will try and get the Kiewa Hydro construction video.

8.5 *State Trustees session* – Ruth outlined the value of this session particularly in regards recent changes to legislation/regulations. Invites to be circulated at the BBQ.

8.6 *Alpine Health Planning Forum* – Dick will attend. There is concern about funding for current programs. This could impact on the availability of the services provided by Maureen to the Men's Sheds. Ian to prepare a background list for Dick to take to the Forum.

8.7 *April Meeting Dates* – Decided to stay with listed dates.

8.8 *Football Gate Duty* – The football starts with a match at Mt Beauty on 5th April. We will call for volunteers at the BBQ.

8.9 *Men's Shed BBQ* – The wheels on the BBQ need repair. Ian to arrange.

8.10 *Construction Records* – We need to record all hours spent in relation to the construction of the shed. John H will set up a spread sheet for the consolidated record. Financial control is paramount and Ian will oversight invoices to check progressive expenditure against various budget items. Graeme offered to record the Shed's history.

8.11 *Shed Construction* – Updated sketches are with Tony Gentile for revision of his quote. We will now supply the windows and doors and he suggested that we consider including the verandah in the initial construction. The shed height may need to be raised to allow the desirable clearance under the verandah. Following receipt of that information Dick & Ian will meet with Bruce Howie & Sam Porter from the Alpine Shire. The standard of drawings for the permit applications will be discussed to see what is required.

8.12 *Grants* – It was agreed that we seek a grant(s), when an opportunity arises, to fund training for First Aid for members and also for relevant OH&S training. Alpine Health can also assist with the latter. If we are to offer our services for the Scoby 3 Peaks Challenge we will need training in traffic control.

8.13 *State Government Logo* – We need to include the Government logo on all outgoing correspondence relating to the shed construction.
