## 2017 Annual General Meeting

### Minutes

Held at the Shed at 12:50 pm on Friday 15th September 2017

1. **Presidents welcome:** Dick opened the meeting by officially welcoming all present and thanked them for supporting the Shed.

#### 5. Reports

5.1 **President** Dick summarised another year of activities at the Shed. He mentioned the projects of dust extraction, deer guards, spinning wheel, repairs to furniture, manufacture of knife blocks, the kitchen bench, Shed surrounds, etc. Dick thanked the many members who contributed during the year, in particular Mark & Maureen Hardidge for the work that they put into Footygate and monthly BBQ's. He also mentioned the safety audit and our response, and referred to the Women in the Shed courses that are run by Dick and Irvin.

5.2 **Treasurer** On behalf of Paul (who is overseas) Ian H highlighted a very successful year financially. The position has improved markedly due an operating surplus of around \$14000. The *main sources of income* were: Footy gate raffles, donations, project work completed, garage sales and membership fees. BBQ income covered our costs. *Major expenses* were insurance, telephone & internet, water & sewerage, electricity and workshop supplies. Major projects for the year included the shade sail installation and the installation of the dust extraction system – both funded mainly by grants.

5.3 **Shed Construction Manager** Ian H outlined the work that had been completed over the last 12 months including the Shade Sail, Dust Extraction system, landscaping and garden. Work started on the west side security fence and the next major Shed enhancement will be a verandah on the west side.
