7. Membership Fees: The Shed Committee had recommended that the annual fee be increased \$50. However, it was moved by Mal Darwent and seconded by Paul L'Huillier that the annual fee be increased to \$55. Passed

8. Election of the Committee: Ian Howley conducted the elections. It was moved by Don Terry and seconded by Mal Darwent that the number of ordinary committee members remain at eight. Outgoing Secretary Noel McDougall is also not nominating for re-election and the meeting thanked Noel for his years of service as Secretary.
